

Application process

Please ensure you read the information below before applying.

- a) You must complete all information required in this application form and submit your application through info@imaste-ips.com with VIDEO COMPETITION in the subject line. Only the official form of application will be accepted. This description of the application process and the terms and conditions below form part of the application form.
- b) The closing date for receipt of applications is **Friday 30th March 2012**. Applications received after this date will not be included in the process. If your application was successfully received, you will receive an email to confirm this.
- c) If your application is successful, you will be sent an email after the closing date.
- d) The judging will be under the supervision of Imaste and all decisions made by Imaste will be final.
- e) If you are successful and win the competition, you will be asked to reply and complete the requested details in full. If you do not respond by the specified date, your application will be discontinued without notification.
- f) Your application, including all images and music must be original in order to be used in the competition.

Please check that emails received from info@imaste-ips.com are added to your 'safe sender' list. This will prevent emails being sent to a Junk or Spam folder and ensure that you receive all emails setting out the actions which you must take to comply with the application process conditions.
